The company was founded in 1977 in Toronto Canada, with little to no West Indian store in sight at that time, and because of the love and passion of Lionel that he contributed to the company, today the operation has grown to housing over 7,000 products, adhering to quality and commitment has grown to become one of the best-known, most-loved brands throughout the world, with distribution centers in six U.S. states -- New York, Chicago, Maryland, Boston, Connecticut, Orlando & Miami, and three more centers in Toronto(Main office), Montreal and Vancouver, Canada.

Lionel M. Bedessee started his business in Guyana his homeland back in the early 1950's selling products such as, rubber balls, twine, balloons, and cricket balls on his bicycle throughout Corentyne Guyana. The business grew rapidly to wholesale and a full sports department to include products such as: kitchen chair, Singer sewing machines, Linoleum carpets, florescent tubes, enamel kitchenware, lead sheets, rope and twin. He then took a bold move and immigrated to Canada with his family in 1971. While there, he noticed a lack of Caribbean & West Indian products in the market. He was a brilliant innovator, entrepreneur and with this spirit became the pioneers of the Caribbean / West Indian Food business in Canada and USA. He traveled the world seeking authentic products and brands that was once exported to the Caribbean.

# **About CCAC**

The Council of Caribbean Association - Canada (CCAC) is a registered non-profit umbrella organization comprising of fourteen (14) registered Caribbean national Associations operating in the GTA.

The current participating member organizations are: Antigua & Barbuda Association of Toronto (ABAT), Alliance of Guyanese Canadian Organizations (AGCO), Barbados Canada Association (BCA), Commonwealth of Dominica Ontario Association (CDOA), Grenada Association Toronto (GAT), St. Lucia Toronto Association (SLTA) and St. Vincent & Grenadines Association of Toronto (SVGAT).

Launched in 2009, the organization aims at among other things, to work with other organizations in our community that represent and cater primarily to people of Caribbean descent who have made Canada their home. CCAC focuses on the following areas: (1) to assist young persons in their pursuit of higher learning and sustainable employment; (2) to work with our seniors to better provide them vital information to enhance their productivity in the golden years.

The CCAC is administered by a Board of Directors comprising of a representative from each of its functioning member associations. Three representatives from each member organization make up the Council.

# **CCAC's SCHOLARSHIP PROGRAM**

#### Purpose:

To encourage and assist youth from Caribbean countries who are currently resident in Ontario to pursue their educational goals at university or college level.

To recognize academic efforts; community involvement and contribution in the Caribbean community in Ontario.

## Number and Value of Awards:

CCAC will annually determine the number of bursaries it will make available for open competition. The value of each bursary will be Cdn. \$1,000.00 to successful applicants. The bursary is non-renewable, non-transferable and is to be used towards full course study, leading to a first diploma or degree. A student can only receive the bursary once.


