#### CONSTITUTIONAL AMENDMENT

In our quest to operate in compliance with the *Ontario Business Corporation Act 1990*, our members elected a 9-member board of directors at the Annual General Meeting held on January 27, 2013. The elected members are: Marcia Farrell, Prudence Morton, Garnet Samuel Harry, Claudius Samuel, Kinda Edwards-Keizer, Bernadette Ryan-Phillips, Cornetta Mason, Francelia George and Monty Providence.

Subsequent to the elections at the Annual General meeting, the board members met on February 03, 2013, in Ajax, ON and elected a president and a secretary from amongst themselves. From that meeting, Marcia Farrell was elected president and Prudence Morton was elected secretary.

For the first time in the organization's history, there is a Board of Directors which is separate from the Executive Committee. The Board of Directors will govern the organization and implement long term plans while the Executive Committee will continue to be responsible for the day to day running of the organization. As it stands, not all board members sit on the Executive Committee.

We encourage all of our members to be a part of this transitioning period by attending meetings regularly and share your views and concerns in an open forum.

## IMMIGRATION MATTERS:

CHANGES AFFECTING SPONSORSHIP

## CONDITIONAL PERMANENT RESIDENT

VISA: As of October 25, 2012, permanent resident applicants who have been in a marital, commonlaw or conjugal relationship for two years or less and have no children with their sponsor will only be given conditional permanent resident status for the first two years. Full permanent resident status will only be granted to applicants after the applicant and their sponsor have been living together in a conjugal relationship for two years after the day on which they became a permanent resident.

If immigration officials has reason to believe that a conjugal relationship does not exist between the applicant and his/her sponsor, an investigation may ensue. Random assessments are also planned to see if applicants and sponsors are in compliance of the two-year condition. If immigration officials finds that the applicant and sponsor are not together during those first two years, the applicant could lose their permanent resident status and be removed from Canada.

The two year condition will cease to apply if the sponsor dies during the two-year conditional period, provided that it is deemed that the couple remained in a genuine relationship until the sponsor's death. In cases where abuse or neglect is evident, the two-year condition shall also cease.

There is no difference between having conditional permanent residence versus normal permanent residence except for the two-year condition.

#### FIVE YEAR SPONSORSHIP

**BAR:** Restrictions are in place to prevent all Canadian citizens and permanent residents who were sponsored here by a spouse, common law or conjugal partner from, in turn, sponsoring another spouse until the sponsor has been a permanent resident for at least five years from the date he became a permanent resident.

If the applicant's spouse dies he/she cannot sponsor another spouse, common-law or conjugal partner for another five years. In cases involving abuse, the abused cannot divorce and sponsor a new partner for five years. After the five year period has elapsed, a new spouse, common-law partner or conjugal partner may then be sponsored.

**CRIMINALITY BAR:** Sponsors convicted of an offence of a sexual nature, or an attempt or a threat to commit such an offence against any person are barred from

sponsoring anyone. Sponsors convicted of an indictable offence involving the use of violence and punishable by a maximum term of imprisonment of at least 10 years, or an attempt to commit such an offence, against any person are also barred from sponsorship.

Convictions relating to an offence that results in bodily harm or an attempt or a threat to commit such an offence against a current or former relative of the sponsor, the sponsor's spouse, common-law or conjugal partner, or other current or former family member of the sponsor's spouse, common-law or conjugal partner renders sponsors as ineligible to sponsor.

Exceptions may apply depending on the nature of the conviction, whether the conviction occurred in Canada, how long ago the conviction occurred, and whether a pardon was granted.

Prior to contemplating to sponsoring a family member, sponsors should ensure that these bars and any other eligibility criteria render them as being ineligible to sponsor rather than submitting an application to sponsor and having it rejected.

The following is an article taken from the Vincentian Newspaper, dated January 11, 2013. The article was written by the Honourable Girlyn Miguel, Minister of Education in SVG. It is being reprinted here as we believe the message is relevant to students, teachers and parents everywhere.

I bring you greetings from the Ministry of Education as the New Year begins and wish that peace, prosperity and success will accompany each student, teacher and their families throughout the year and beyond.

An inspirational quote, which I hope you will always remember and allow to guide you, reads thus: 'It is your road and yours alone, others may walk with you, but no-one can walk it for you.' This is meant to tell you that your future, success and your destiny depend largely on your own individual efforts, and, to a lesser extent, on the type of support which you receive from your family, friends and teachers.

At this time of economic hardship, as a nation we have to work together to ensure that our country prospers and is able to withstand the shocks being experienced elsewhere. Each person, young or old, has a role to play in making our country resilient and in ensuring its survival.

Principals, your role as administrators and instructional leaders is important, in ensuring that our schools are effective schools, and safe spaces, in which teachers and students conduct the important business of teaching and learning.

Teachers, your role as instructors and guides, is of equal importance in ensuring that our students are equipped with the knowledge, skills and attitudes needed for their personal, cognitive and psychosocial development, if they are to become stable, well-adjusted individuals, who can contribute to the economic survival and productivity of our small island state.

Parents, guardians and caregivers, your role are fundamental in the lives of our nation's youth. It is within the bosom of the family which you create, that the future success or failure - the destiny of the youth - is determined. This is determined by the quality of nurturing and socialization which you provide during the formative years. It is your responsibility to show the youth under your care, how to walk, and to walk with them through their formative years, through their schooling, and even into adulthood; for, as parents and guardians, you are never allowed the privilege of resigning unless you wish to see your children fail. Your role is also to support the schools, so that there is a close and supportive link between the home and the school. That your children's education does not become the sole responsibility of the school, but remains a collaborative effort between these two institutions in your children's lives.

Over the past eleven years, the Ministry of Education has embarked on a number of initiatives, chief among them is the provision of spaces in the secondary school system for each child of secondary school age; this, was done under the umbrella of Universal Access to Secondary Education. Naturally, this initiative cannot bear the fruit which it is intended to bear, unless all of the parties to which I referred above, fully recognize and embrace their respective roles and responsibilities, and dispatch these with the requisite diligence, dedication and compassion.

Every child can succeed and must be given the opportunities to do so, by those charged with the responsibility of ensuring our children's success. During the course of the past eleven years, teachers and school leaders were able to benefit from opportunities for further education, to ensure that they possessed the training and skills needed to address students' learning and psychosocial needs. Five additional secondary schools were established, and more places were created at the primary level. Additionally, nine government operated Early Childhood Education centres came into being in 2009 in order to increase equality of access to education at this level to an underserved sector of our population. Along with these initiatives, came the establishment of units within the Ministry of Education with the mandate to oversee quality in the provision of Technical and Vocational Education and Training as well as postsecondary education.

The past year, however, has not been without its tears and trials. We are aware of the fact that many of our students are experiencing difficulties and appear not to have the coping skills needed to surmount these. As a result of this, plans have been set in motion, to strengthen the teaching of Health and Family Life Education in the schools, and to extend counselling services. The support of parents is critical to the success of this venture. We all need to work together to ensure that our students are provided with the care, support and comfort which they need, as they move from one stage of development to another. Educating our students is a collaborative effort.

In closing, I express gratitude for support and cooperation from my colleagues, the staff of the Ministry of Education, all principals, teachers and support staff in our schools and centres of learning.

#### Prevent Diabetes...One step at a time

The Association qualified for funding from the Toronto Public Health to provide information on **type 2 diabetes prevention.** In order to provide this information, persons had to attend three days consecutively before one can qualify as a peer leader. The Association submitted eight names but only five people were able to attend the three days workshop from 9:00 am to 4:00pm.

Each peer leader was given resources and various suggested activities to help people in their community enjoy a life that includes healthy eating and physical activity, along with useful information to support their personal decisions to change their lifestyles. After the training completed, peer leaders coordinated a five informational sessions on prevent diabetes on Saturday, January 12, 2013, and Saturday, February 09, 2013, from 10:00 a.m. to 3:00 p.m.

The sessions were well attended. Participants had opportunities to participate during each session and this they did with much enthusiasm through the sharing of personal experiences. The session topic includes: Session 1 - welcome to Prevent Diabetes...One step at a time program; Session 2 - assessing Your Risk for Type 2 Diabetes; Session 3 -

Eating Healthy with Canada Food Guide; Session 4-Planning and Shopping for Healthy Meals...While on a Budget; and Session 5 – Review and Celebration.

Participants were asked to create realistic, specific weekly goals that can be worked on regularly and one that last for a long time, that is, SMART goals.

- **Specific** your goal should specify just what you want to achieve
- Measurable you should be able to measure whether you are meeting you goal
- Achievable Your goal should be something that you are able to achieve
- Realistic Your goal should be something that you can achieve with the resources that you have
- **Time** you should decide when you want to achieve the goal

In discussing Healthy Eating Habits, we touched on various food groups, the proper potions with the four food group represented according to Canada Food Guide for a BALANCE DIET. Generally it was a productive 2 days with living by example, healthy snacks and lunches were provided. The participants vowed to change their lifestyles ... One step at a time and to share the materials handed-out with friends and family. It was a productive and enlightening program and we are motivated to continue with this project.
