# **Investing in the Diaspora**

As a new government, the Unity Labour Party Administration did a quick assessment of the foreign policy that it inherited and decided that more emphasis was required on servicing the needs of Vincentians living in the Diaspora. It was decided to immediately establish a consulate in New York City. A year later, the office in Toronto was expanded and it is now headed by a Consul General instead of an Honorary Consul. This brings to seven the number of offices in North America servicing the needs of our citizens.

I will summarize briefly the role that is envisioned for Vincentians in the Diaspora and then describe the function of each of our offices.

We firmly believe that the government of St. Vincent and the Grenadines can and should make a contribution to bettering the standard of living of all Vincentians whether they live at home or here in the Diaspora. For that reason, the government has worked with statutory bodies, private entities and organizations to facilitate greater access by Vincentians in the Diaspora to benefits and investment opportunities previously available only to Vincentians resident in St. Vincent and the Grenadines. These include enacting legislation to allow all Vincentians to participate in the National Insurance Scheme, promoting the benefits of joining local credit unions and facilitating greater participation by Calypsonians in Vincy Carnival. importantly, there is increased lobbying by our Embassy on Capital Hill in Washington for liberation of immigration legislation in order to provide greater mobility and economic empowerment to Vincentians currently undocumented.

At the same time, we understand and appreciate both the political and economical importance of organized and active Vincentian communities in the Diaspora. In a future issue of this newsletter, I will go into more detail about how we can harness and utilize our power more effectively for the benefit of our homeland.

# Role of The Embassy of St. Vincent and the Grenadines to the United States

Our primary responsibility is the maintenance of good relationship with the United States. To do this, we interact mainly with the White House, the State Department, and members of both the Senate and the House of Representative. We utilize our contacts established through "pounding the pavement" to try and influence legislature that can impact on St. Vincent and the Grenadines or Vincentians in the Diaspora. We also monitor the activities of the USAID, the US Agency responsible for assistance to the region to make sure that any aid given reflects our priorities for development.

We also interface with the representatives from other countries. As the preeminent development country in the world, most

countries have a permanent presence in Washington. We have been utilizing this office and the Permanent Mission to the United Nations to establish and maintain functional relationships with other countries. In Washington, because we serve the dual function as Embassy and Permanent Mission to the Organization of American States, we have been able to forge strong alliances with the other member states in the Americas.

As I indicated before, I want to dedicate a separate article to other interaction with the Diaspora, and I am aware that in a previous issue, Consul General E.B. John in Toronto outlined the functions of the Consulate. Likewise, those aspects of the Embassy's work are carried out through the Consulate established in New York City.

### **Vincy Artists**

St Vincent & The Grenadines has given a lot to the Art world. Many talented people have despite the lack of infrastructure and support managed to make an impact on the world of culture. We can for example talk about Ellsworth "Shaeke Keane, a trumpeter who along with Jamaican saxophonist Joe Harriott managed to change the face of British Jazz before moving onto Germany where he became known as the European Louis Armstrong. Many of us know about the McIntosh's who ruled the music world in St Vincent before moving onto North America where their talents were soon felt on the big city musical scene. Names like Frankie McIntosh and Syl McIntosh are very prominent in musical circles.

In the world of stage and screen, I grew up hearing about the great work of the St Vincent players and writers like Tim Daisley. New Artist Movement (N.A.M.) ruled the stage in my day when I lived in St Vincent. Many great actors came out of that group and unfortunately many of them left St Vincent and did not continue or were unable to pursue work in the theatre, but yet, a few had risen to prominence despite the odds. Right here in Toronto Ardon Bess has become a leading actor working both on stage and screen, winning awards in the process. Children born of Vincentian parents are showing up in bit parts on TV movies. People who love the old Shaft movies can catch a glimpse of Actor/dancer Tracey Connell in a bit part in that movie. He also acted in some seventies Canadian movies before returning to St Vincent.

The world of visual arts has not been spared by many Vincentian artists who have had exhibits at home and abroad. I always remember looking at the work of one Lennox Dink's Johnson with pleasurable wonder. In the world of writing Canadian artist would have gotten a chance to see some of the work of our present crop of writers as part of the Caribbean Canadian Literary Festival June 19 – 21, Writers like Michael MacMillan who was born of Vincentian parents in England is a writer, professor, and producer. Nigel Thomas, author and professor lives in Montreal, the home to another prominent writer, Trevor Joyette, both born in St. Vincent. The ladies were represented by Marcia Harold-Hinds whose epic poem The Saga Of Hairoun was published in 2002. She resides in Barbados. This writer who has been struggling to make it on the Toronto/world scene is having his best year so far and besides representing St. Vincent and the Grenadines at the Festival I am getting ready for my production in this year's Toronto Fringe Festival with a play called Back Home.

Starting this month Insight will try to highlight the achievements and present activities of many of our Vincentian artists that struggle to make it in the world of the Arts.

# A contribution by Elma Gabriel at SVGAT Mothers' Day Dinner, 2003.

When I decided to give this speech today, I had to compromise between talking about this day that commemorates us mothers, or about something different. Like, questioning ourselves as to what, we want as people living in Canada. Then I thought, since I am a mother whatever I say to you today is in celebration of our struggles through the years. As I reflect on my time living outside of St. Vincent and the Grenadines and the way Vincentians in Toronto express their cultural identity, I ask myself, "Why I am so troubled about the future of Vincentian organizations in Canada after our generation passes?

What are our legacies in these foreign places we now call home?" For the past couple of years I had the privilege to see and experience the many talents in different places of our community, including Montreal, New York, Ottawa and our own Toronto. I was also overwhelmed by the population of Vincentians outside St. Vincent and the Grenadines. That I said to myself, maybe one of these days I will try and find out more.

Take my own census and create my own study on the Vincentian communities of Canada. I was excited to know that there are many of us out here but this excitement slowly dissipated when I wonder about our legacy as a community to our offspring, their offspring's, the society in which we live and the one from which we came. Looking around I see nothing, yet inside of us there is so much to give and I wonder why aren't we giving to ourselves the goodness of our hearts. We landed in many parts of Canada, some of us directly from St. Vincent & the Grenadines, some of us via Europe, then North America.

What do we really want as a people? Is it a sense of belonging, or the vanity of our individuality? Our lack of support of the Symposium in New York and our Membership drive, have opened my eyes to see a bit clearer, why we are failing as a culture. Why we are unable to influence even our own self as a people, much less, the respect and support from our Vincentian Government, to accept us as the representative of the Vincentian community in Toronto.

Reasons are, we continue to look at ourselves as an invisible minority, relating to a "have and a have not" kind of social thinking. Our values are measured by the values of St. Vincent and the Grenadines, which many of us aspire to be among the elites of that culture, rather than to the values of our Canadian reality. In other words, after being out of St. Vincent and the Grenadines for many years, we still see ourselves as Vincentians however, in this society, we are simply tossed within the multicultural minority of the Canadian /North American, globalize world. Our children are classified as first generation Canadians. This in itself is a cast of two cultures -- The invisible minority and multicultural Canadian identity while, we as naturalized Canadians adhere to a Vincentian mentality. Some of us would look at these factors as negative to our present interpretations of Vincentian culture while, some may see them as positive elements that relates to our Vincentian Canadian reality.

Depending from which perspectives we are looking, some of us may feel that we have "arrived" while others are still looking. The end result is that no matter how we look at ourselves in this society, we are immigrants of a minority status. Our Vincentian status is better recognized when we celebrate as a people. Therefore, the larger the gathering the more unity, influence, respect and recognition for all Vincentians. Not only by other cultures around us but by our offspring's and future Vincentians who, are the inheritors of our accomplishments; including the achievements of our Association.

We will always be Canadian -Vincentians spiritually connected to each other by the land of our birth. By the land of our fore parents, where we ate the same foods, swam in the same waters, looked at the same sunsets, shared the same breeze and enjoy the magnificence of La Soufriere and the Botanic Gardens. Where we roamed the same beaches shared the same history, looked at the same "Iron man", yes! Weathered the same storms and rose when it became calm. So, let us mark this year as the time we charter a new course for the stability and future of our organization.

One behalf of the St. Vincent and The Grenadines Association of Toronto; I thank all mothers, daughters, husbands, wives, sons and fathers and hope that this day would be one remembered for a long time. I would also like to thank all those who created this organization many years ago. It is a part of our legacy and history that gives me a sense of belonging and confidence to move beyond our colonial upbringing. I wish you all very happy Mother's day.

# Merger gets off the Ground

A holding company, Caribbean Airlines (Holding) Ltd, would be incorporated in T&T within two weeks, to hold shares within BWIA and LIAT as several governments prepare to reorganize the region's airline business.

Prime Minister of St Vincent and the Grenadines, Ralph Gonsalves, yesterday said that the holding company would act as a frame for the two bankrupt companies. "We have established a clear nexus between BWIA and LIAT, but you must have a frame and that frame is the holding company," Gonsalves said during a news conference at the Central Bank of T&T, Port-of-Spain, yesterday. The holding company would be subject to approval from the Registrar of Companies. This, he said, may result in a possible merger between the two airlines, creating one major Caribbean airline. "This will be a structure helping us to reorganize the airline business in the Caribbean and owning that business," Gonsalves said.

Gonsalves had earlier met with Prime Minister Patrick Manning, Junior Finance Ministers Ken Valley, Conrad Enill and Christine Sahadeo and Labour Minister Franklyn Khan to discuss the matter. He also met with the deputy PM of Antigua and Barbuda, Robin Yearwood, Barbados' Minister of International Transport, Noel Lynch, BWIA's Chief Executive Officer, Nelson Tom Yew, LIAT's CEO Garry Cullen and other LIAT and Caricom officials.

Talks of a merger between the two cash-strapped airlines have been bouncing around for some time now, but it is only after a report from a yet-to-be appointed technical co-coordinator that the two leaders would decide on the feasibility of the venture. Gonsalves said the decision to co-ordinate a holding company came after an interim report from a Barbadian technical team appointed on April 13. The appointed technical co-coordinator's job would be to prepare and co-ordinate the implementation of a detailed plan for the establishment of the new company, and the restructuring and rationalization of the operations of BWIA and LIAT, he said.

The technical team would also continue to work with the cocoordinator to determine the strategic and operational issues for the new airline and the equity requirements for the holding committee. The leaders also decided that other financial contacts should be sought, adding that the airlines would restructure their efforts towards viability as a pre-condition for any further public sector participation. Manning said T&T would provide initial funding for the retention of the services of the technical co-coordinator, but explained that the cost would be "minimal".

#### The aviation problem

The decision by regional leaders, meeting in Port-of-Spain yesterday, to establish a holding company to facilitate the establishment of a regional airline is a neat solution to a possibly messy problem. The problem: How to establish a properly-capitalized, low-cost regional carrier in the Eastern Caribbean at the least cost to the owners – presumably regional governments, the regional and international private sector and the workers.

The holding company, Caribbean Airline (Holdings) Ltd, would own a majority of shares in two existing airlines – BWIA and LIAT – but could hold shares in other airlines which may be encouraged to join. BWIA and LIAT would become subsidiaries of the holding company.

#### Who will control it?

As it stands, the T&T Government holds a 49 per cent stake in BWIA – 33.5 per cent by the Corporation Sole and 15.5 per cent in trust for the airline's workers stake. These shares have not been transferred to the workers as yet. LIAT is owned by the regional governments. Twenty-nine per cent of LIAT is owned by BWIA, which also owns 49 per cent of Tobago Express, the air bridge airline, which, like LIAT, flies Dash-8s, a short-haul aircraft. It is likely that the T&T Government, because of its financial strength, would be the largest single shareholder in the new airline. This means that the Manning administration would be in a position to call the shots in aviation in the Southern Caribbean by having the airline based at Piarco, choosing the new CEO and dictating labour terms. It also means that the T&T taxpayer would be called upon to fund the airline, at least in its initial stages.

### Why a holding company?

Holding companies are companies which have control over several operating companies. When Royal Bank decided to embark on regional expansion, it opted to form a holding company (RBTT Financial Holdings) which would own its local and regional subsidiaries. Likewise, Guardian Life. The advantage of a holding company is continuity – the existing airlines would be able to maintain their identities and their route rights. The obvious disadvantage is that the new owners of the airline may not be able to force new wage and salary terms and conditions on the company's employees.

#### Other options?

The governments could have pulled the rugs on both airlines and attempt to form a new structure from the ruins. This would have been an expensive option with millions being paid in retrenchment costs. There is also the issue of the debt that both airlines carry, especially to the airline leasing companies.

#### **OVERSEAS MISSION**

The Heads of overseas Missions and Consulates recently met in Kingstown to review their work and to plan strategies, which will bring greater benefits to the people of St. Vincent and the Grenadines.

The consultation, which is held annually, is aimed at enhancing relations and improving the operations of the overseas offices. High Commissioner to the United Kingdom - Cenio Lewis; Permanent Representative to the OAS and Washington - Ellsworth John; Ambassador to the United Nations - Margaret Ferrari; Consul General in New York - Cosmos Cozier and Consul General to Toronto - E. Bernard John attended the event.

Items on the agenda include Administrative, Political, Economic and Trade Issues. Reports on the operations of their Missions and Consulates over the last year were to be tabled.

## IMPORTANT VISA NOTICE

The United States of America (USA) have imposed visa restrictions on Canadian Landed Immigrants from Commonwealth Countries (this includes all OECS Countries). Bottom line, this means that if you are a landed immigrant in Canada, you **CANNOT** visit the USA without a VISA. These restrictions took effect as of March 17th, 2003. The USA Embassy has indicated that it can take up to 30 days or longer to process a VISA application, so you should apply early if you have plan to travel to the USA. To make an appointment to apply for a VISA you must call 1-900 451-2778 (\$2.00 per minute).

For those of you who qualify to apply for Canadian citizenship, now may be a good time to do so, since the visa restrictions do not apply to Canadian citizens. Usually you qualify to apply for Canadian citizenship after you have been living in Canada as a landed immigrant for three years. The laws of St. Vincent and the Grenadines and Canada allow you to have dual citizenship; therefore, you have nothing to lose by becoming a citizen of Canada.
