### Our Response To Hurricane Relief

## PROTECTING THE "VULNERABLE CHILD" IN OUR SOCIETY

## **Child Protection and the Child and Family Services Act**

October is known as Child Abuse Prevention month which centers on protecting vulnerable children. The *Child and Family Services Act* governs this area of law which is the legislative scheme when a child is believed to be in need of protection.

### <u>Paramount Purpose of the Child and Family</u> Services Act

The *Child and Family Services Act* states that the primary purpose of the act is, "to promote the best interests, protection and wellbeing of children". In order to determine the best interest of a child the court examines a comprehensive list including but not limited to the following factors:

- 1. The child's physical, mental and emotional needs, and the appropriate care or treatment to meet those needs.
- 2. The child's physical, mental and emotional level of development.
- 3. The child's cultural background.
- 4. The religious faith, if any, in which the child is being raised.
- 5. The importance for the child's development of a positive relationship with a parent and a secure place as a member of a family.
- 6. The child's relationships and emotional ties to a parent, sibling, relative, other member of the child's extended family or member of the child's community.
- 7. The importance of continuity in the child's care and the possible effect on the child of disruption of that continuity.
- 8. The merits of a plan for the child's care proposed by a society, including a proposal that the child be placed for adoption or adopted, compared with the merits of the child remaining with or returning to a parent.
- 9. The child's views and wishes, if they can be reasonably ascertained.
- 10. The effects on the child of delay in the disposition of the case.
- 11. The risk that the child may suffer harm through being removed from, kept away from, returned to or allowed to remain in the care of a parent.
- 12. The degree of risk, if any, that justified the finding that the child is in need of protection.
- 13. Any other relevant circumstance.

### **Defining the Term "Child in Need of Protection"**

A child may be in need of protection if he/she has suffered physical harm, sexual molestation, sexual exploitation, emotional harm, inadequate care or has been abandoned or been subject to a pattern of neglect.

### Dealing with the Children's Aid Society

- (a) Do not become angry and hurl insults at the child protection worker.
- (b) Do not cry and have an emotional meltdown as the worker may interpret this as being emotionally unstable, instead be calm, respectful and rational.
- (c) Take the time to listen to the concern of the worker regarding your child and ask him/her what is required of you as a parent, be cooperative.
- (d) Neglect, if the child protection concern is that your six (6) year old was left unattended at home, you failed to properly feed and clothe the child or take him/her to medical appointments or school, then make alternative care arrangements, obtain the necessary service providers and take a parenting class.
- (e) Physical harm, if the child protection concern is that you used a pot spoon to hit the child and he reported the matter to his teacher, take a parenting and anger management class.
- (f) Sexual harm, if the child protection concern is that while in your care the child was touched in a sexually inappropriate manner, then undertake a parenting class, attend a reduction of sexual harm program and put measures in place to protect the child.
- (g) Emotional harm, if the child protection concern is that you are shouting, threatening and using foul language to describe the child a remedy will be to take a parenting, conflict resolution and anger management class.
- (h) Drug and alcohol abuse, if the child protection concern is substance abuse, then attend a program for substance abuse and a parenting class.
- (i) Mental health issues, if the child protection concern is due to mental health issues, then see a medical professional and obtain the necessary care, either talk therapy such as Cognitive Behavioural Therapy or medication.
  - (j) Hire a lawyer. The area of law governing child protection is complex and both the rights of the child and parent require competent representation. Typically counsel from the Office of Children's Lawyer will be appointed to provide legal representation for the child. By hiring a lawyer your parental views can be addressed with the goal of having the child or children returned to your care.



## IMMIGRATION MATTERS

### THE REALITY ABOUT IMMIGRATION

The stark reality about Canadian immigration is that the applicant either meets the eligibility criteria for the program he/she is applying for or not; an application can either be accepted, rejected or refused; and/or the case appeals to immigration officials' assessment and/or discretionary judgment or not. The discretionary judgment could be quite unpredictable and may weigh in the applicants' favour or not. Regardless of the type, nature, circumstances, completeness, or documentary evidence contained in an application package, once the case completes processing, the decision (approved or refused) needs to be communicated to the applicant and he/she has to deal with the decision. Obviously approvals are the easiest cases to accept. The issue lies with refusals. Most people have a difficult time dealing with rejection or news that is not to their liking.

The usual first step for immigration applicants is the consultation. Authorized immigration representatives are required to be forthright and competent in their areas of practice. Being forthright may entail telling a client or prospective client something they may not be pleased about hearing; however, the truth must be told. As an authorized immigration representative I pride myself in being straightforward rather than telling clients what they would like to hear. They tell me about the reality of their case and I tell them about the realities about immigration - the policies, the procedures, the processes, the officers, etc. Sometimes the realities about immigration may be positive and thus easy to communicate and accept and other times it may not be positive and thus not easily accepted. Whichever way it is it must be communicated and dealt with. During consultations, when it comes to unpleasant news, I do my best to soften the blow by providing suggestions as to what may be done in preparation to meet eligibility criteria or to make a case stronger.

The reality about immigration is that the decision makers at the visa offices are not perfect and thus subject to making errors, ill judgment, and critique. The reality about immigration is that an application may have all the makings for success but may be refused or it may have the makings of a weak case but may be approved. Each case is assessed on its own unique merits and viewed under microscopic lens with an "if/then" and "what if" approach in preparation for submission to the appropriate government division. The reality about immigration is that authorized representatives and applicants must be cognizant of

these if/then or what if scenarios and work cases to the best of their abilities. The reality about immigration is that a case should be viewed from the decision maker's perspective and not necessarily from the subjective perspective and hopes of the client.



The reality about immigration is that immigration representatives and clients have to comply with the *Immigration and Refugee Protection Act (IRPA)* and the *Immigration, Refugee Protection Regulations (IRPR)*, and the *Citizenship Act*. We also have to adhere to the varying rules and procedures of the many divisions and departments (i.e.: Refugee Protection Division (RPD), Refugee Appeal Division (RAD), Immigration Appeal Division (IAD), Immigration Division (ID), Canada Border Service Agency (CBSA), etc.),

Another reality about immigration is that, from time to time pilot projects are launched, new Bills are passed, and internal policies and procedures change, etc. For example, applications to sponsor parents and grandparents used to be accepted on a first come/first serve basis starting on the first business day of the year with a maximum cap on the quantity of applications that shall be processed. This was abruptly changed this January 2017. Immigration, Refugees and Citizenship Canada (IRCC) switched to a "lottery" type system whereby applicants had to submit an online submission form expressing their interest in sponsoring their parent or grandparent and hope that they get picked to

actually apply. Keeping abreast of and garnering an understanding of these new initiatives and changes plus understanding new Bills is vital to us representatives so that we may present alternate options to clients or prospective clients at the consultation, application and post application stage and better serve them. This is why hiring someone who specializes in immigration and is competent and forthright is important.

I treat clients and potential clients the way I would like to be treated. The stark reality about immigration is that not everyone may meet the stringent eligibility criteria to obtain the immigration status that they hope for.

With advanced planning and preparation, plus the guidance of a competent and forthright authorized immigration representative, applicants can maximize their chances of meeting eligibility criteria and their chances of having their case approved.

**SVG-Taiwan:** Celebrating friendship



Raising a toast, across political boundaries, to mark the 106th anniversary of Taiwan's National Day.

The Republic of China on Taiwan has progressed tremendously Over the years, and has now become a power and force to be reckoned with, not just only in

Asia, but the world.

Taiwan's Ambassador to St. Vincent and the Grenadines, H.E. Baushaun Ger, highlighted some of his country's developments – its economic growth, advances in health care and education, low unemployment rate, and housing reform for most of the disadvantaged people.

H.E Ger further explained that in the first year (2016 – 2017) since President Tsai Ing-Wen took office, she has implemented a number of reforms, including pension and social housing reform.

Today, Taiwan ranks 11th on the index for economic freedom, and the World Competitiveness Yearbook

ranked Taiwan 14th in the world, 3rd in Asia. And it ranks at the top for press freedom in all of Asia. "But that progress today has not come easy with all the challenges," H.E. Ger said.

"Both countries have always worked close together," he said. The government of St. Vincent and the Grenadines was commended for its continued effort to fight for the right for Taiwan to participate in the United Nations. The cause was raised recently at the UN General Assembly when Minister of Foreign Affairs, Sir Louis Straker spoke on Taiwan's behalf. It was also disclosed that the Taiwan government had increased its contribution to some projects in St Vincent, including its contribution to the YES and School Bursary programmes.

"So, we are here celebrating a country that has done well, but has extended a hand, and has given us immeasurable assistance. We are here to underscore and renew our commitment to the people of Taiwan," he said. (DD)

### Opportunity opening for SVG's bananas

This is according to Minister of

Agriculture, Saboto Caesar, in part response to a question posed in Parliament by Representative for East Kingstown, Arnhim Eustace, regarding the expected date for this country's recommencement of the exportation of bananas.

"The question is premised on an expectation espoused by the government of St Lucia that the export will reach 20,000 tonnes by the end of the year," Caesar told the Parliament.

He cited the real St. Lucia export figure as at week 40 as 6,060.59 tonnes, adding that information received from the procurement officer for WINFRESH indicated that the expected figure by the end of the year was expected to be 9,000 tonnes.

As far as the local situation was concerned, Caesar explained that although the Black Sigatoka issue was under control, the GlobalGAP compliance was yet to be completed. GlobalGAP is the world's leading farm assurance programme and is intended for fresh products, to ensure produce traceability and compliance with intellectual property laws. This process is expected to be completed by November, and until then, this country will not be able to export bananas to the UK.

WINFRESH, however, expressed an interest in selling bananas from St Vincent to the UK, Caesar said, and the ministry was currently working with two potential exporters in that respect. And while there was nothing preventing persons in the private sector from selling their bananas on the regional market, WINFRESH has also started discussions so to do, the Minister disclosed.

With Dominica out of production, following that country's devastation by Hurricane Maria, there was an opening for bananas in the regional market, especially in the US, British Virgin Islands and the Leeward Islands.

WINFRESH was already pursuing this and openings in St. Kitts/Nevis and Antigua. (DD)

## Avoid disappointments: Ship Christmas Barrels Now (Courtesy of The Vincentian Newspaper)

It's that time of year again when families and friends overseas are shopping for holiday gifts to be carefully packed in barrels and boxes and shipped to St. Vincent, timed to arrive before Christmas.

Shipping agencies take care of the many

details and logistics of arranging everything from delivery of personal shipments to a local warehouse, trucking to the closest sea port, loading on an oceangoing freighter to off-loading in Kingstown. In addition, due to an increase in drug trafficking and terrorist activities, shipping companies are experiencing heightened security at all ports, and there is an increasing necessity for additional export and import paperwork such as customs declarations, duty and tax collections, all involved in the clearing of shipments through a local broker.

For over 30 years, Canada's KLC Shipping has been providing weekly freight service for shipments from Toronto, Ottawa and Montréal to St. Vincent, St. Lucia, Trinidad and Barbados. Today, KLC offers specialized weekly service to St. Lucia, St. Vincent, Trinidad, and Barbados, as well as Full Container Load shipments to the rest of the Caribbean and Latin America, in addition to consolidating commercial freight shipments anywhere in the world.

Through the years, KLC has been a familiar face in the St. Vincent and St. Lucia communities, frequently reaching beyond the call of duty to assist other communities in need. During an interview with the Vincentian, KLC president Ken Chitolie shared that KLC had not only made a significant financial contribution to the Dominica relief committee, but had worked with them in a consulting capacity, arranging shipping services to that hurricane ravaged island.

According to Ken Chitolie and customs broker Wayne Chrichton, President of Arabesque Inc. in Kingstown, the volume of barrel shipping this year is predicted to increase substantially. Considering the thousands of barrels that are shipped, most barrels arrive on time, in perfect condition, however, each year, a number of families face frustration and disappointment over not receiving their barrels until into the New Year.

On behalf of KLC and his fellow shippers throughout the Diaspora, Ken offers the following advice to everyone planning to ship barrels and packages to family and friends in time for Christmas: Ship early: (The very last shipment, barring any interference by Mother Nature, such as late season hurricanes or other storms at sea, will leave Toronto on or before December 1st, arriving in St. Vincent for clearance and delivery on December 17th). Document all goods being shipped and do not risk sending any prohibited or falsely described goods; Pack all items carefully, especially anything that may be fragile. If you do not use a barrel, be sure other containers are solid and secure. It is not unusual for a poorly wrapped cardboard box to break open, scattering items on the warehouse floor. Please pass this information along to your families overseas.

KLC freight attempts to avoid increasing shipping rates and have tied any rate increases to the fluctuation in the value of the Canadian dollar. For people sending shipments from Canada, please call the KLC office in Toronto for up to date shipping rates.
