40th Independence Message from Consul General Huggins

On behalf of the Government of St Vincent and the Grenadines, Staff of the Consulate General of St Vincent and the Grenadines and my family, I extend warmest greetings and congratulations of the All Vincentians on the celebration of our 40th Independence anniversary.

I also want to wish the St Vincent and the Grenadines Association of Toronto a happy 50th anniversary. With your slogan to celebrate your 50th anniversary being "Much has been accomplished, Much more to achieve", I can attest to the fact that you have made a tremendous contribution to St. Vincent and the Grenadines in every sector of economic development and I encourage you to continue to make your contribution.

This year we celebrate our Independence under the theme "With Strength, Honour and Dignity, We stand resolute at 40 and Beyond". The Renewal at 40 celebrations has started and will run until Independence 2020. Renewal at 40 is an opportunity for us to take a fresh guard. Build on our strengths and possibilities and to work on our weaknesses and limitations.

Renewal at 40 belongs to all of us whether we live in SVG or in the Diaspora. We must own it for it to be successful. If you hear someone bad talking your country, you have a duty to defend your country. We are not perfect and yes we have many imperfections but we are a proud people who can boast of our achievement in Health, Education, Transportation, Governance, Tourism, Agriculture, Housing, Seaport and airports, sea and river defences, water, electricity, information communication technology.

In every walk of life, we have seen improvements from where we were 40 years ago under various governments. This year forty-eight (48) government scholarships were awarded to students to study at UWI and hundreds more will be awarded to study in various countries around the world. In 1979 we had one (1) national scholarship.

We can celebrate the fact that a country only 40 years old and the smallest country to be voted on the United Nations Security Council as a non-permanent council member between 2020 to 2022. SVG received support from 185 countries out of 191 countries at the United Nations. Some may say that we should dance a yard before we dance abroad but this myopic view can be countered by the fact that this opportunity gets SVG a seat at the table where much can be achieved. I am confident that we have effective leadership and youthful exuberance on our side who will look after our interest. Already we have seen many countries coming to us to seek advice on their own campaign, Canada is one.

SVG is leading the way in conducting explorations so we can be self-sufficient in geothermal energy. We already have installations in renewable energy in solar energy and three recently upgraded hydro plants capable of deliver up to 20% of electricity at peak. We are making our contribution to slowing down the impacts of climate change, as small as we are.

In health, the recently opened Modern Medical Hospital in Georgetown has come in for excellent reviews having delivered quality health care to citizens all over the country although it was designed to service patients from the north east quadrant of SVG.

We have many challenges and we had to admit that like every other country crime is a problem. Pockets of indigence, high unemployment, the threat to Climate Change, political divisiveness. As we move beyond our 40 years, we have to resolve to live better with our neighbours, don't all the divisive politics to cause you to hate your neighbour and lose your friends.

I must acknowledge the invaluable contributions of the Canadian Vincentians, the national associations and charitable foundations in Canada to St Vincent and the Grenadines. Your remittances make up a substantial portion of our GDP and we treasure your support in sensitizing the Diaspora with the political, cultural, social and economic developments in your homeland.

Our job at the Consulate is to offer quality service to the Canadian Diaspora community. As Consul General, I assure you that we will deliver quality service. You deserve it.

Our Honourees for 2019

Honourary Life Member: Kenneth Farrell

Kenneth Farrell is a longtime member of The St. Vincent and Grenadines Association of Toronto Inc. (SVGAT) and has served in several capacities during his many years of service to the SVG community through the Association. Kenneth presently sits on the Board of Directors and has led the Association on four occasions, beginning in 1996 as Chair and then as president in 2002; 2004 and then as interim president in 2006.

During his years with the Association, Kenneth has held various positions on the Executive and Board. He has chaired many committees. In one particular year, due to the lack of manpower in the organization, a decision was made to amalgamate several committees – cultural and recreation, education and sports under one large committee (CRES). It was a challenging task to chair this committee and when the call went out for a Chair, Kenneth volunteered to take on the responsibility. He organized games evenings and led the scholarship committee on many occasions while being involved heavily with the Netball Association and the Cricket Club. Kenneth has been very instrumental in 2013 with the Association's Diabetes and Seniors' Programs by taking a few courses at City Hall to assist with implementing the programs.

While Kenneth's service with the Association has been exemplary, it is his outreach work in the SVG community that has impressed Board members and many members of the Association. One Board member puts it this way, "Kenneth has always risen to the call for assistance. He has been 'out there' in the community, visiting the sick in nursing homes, taking seniors to Drs. appointments, delivering hamper baskets all over the City, being heavily involved with youths in the Netball Association while also being involved with his church." Another member of the Association also had this to say, "Kenneth is very supportive of all SVG organizations and one can always find him at any event in our community. He is also the kind of person you can call on for assistance. If your car breaks down in the middle of the night and you call on him for help, he will be there...no muss, no fuss. Kenneth is a true community person".

In this 50th year of the Association, the Board of Directors of the St. Vincent and Grenadines Association of Toronto Inc. proudly confers on Kenneth Farrell the title of Honourary Life Member of the Association placing him amongst a select group of Honorary Life Members of the Association.

Rosemary Pierre Mohammed

Rosemary Pierre Mohammed was born and raised in the village of Sion Hill, Kingstown, St. Vincent and the Grenadines. She attended the Richmond Hill primary school where she was introduced to sports but it was at the Emmanuel High School in Kingstown where her love of sports blossomed. Rosemary competed in Netball, Track and Field and Long Jump events.

After graduation from Emmanuel, Rosemary says she was floundering a bit as to what to do with her life. She only knew that she loved sports and especially netball. Soon, Rosemary gathered all of the young people in her village and began teaching them the game. It wasn't long before the entire village was involved with Rosemary and her team of young players. Very soon, a Sion Hill Mixed Team was born and the young players were on their way. "After winning a title", Rosemary says, "the team knew it was heading for the big netball tournament and when they set off for the "Big Game", the whole village came along. We were not just playing the game, we were representing entire villages".

During that netball tournament, Rosemary did not realize that her leadership skills and talent were being observed by the netball legend, Mrs. Gloria Ballantyne. It was only when Mrs Ballantyne recruited her later, that she knew her skills and talents were being observed. "Mrs Ballantyne helped me to develop my skills and also assisted the other players to develop their abilities as well." That year, Rosemary joined the Three Jewels Jogger Team and later on the Under 23 National Netball Team. She stayed with that team for several years before going on to the Senior National Netball Team. She was ranked 4th in her position.

Rosemary left St. Vincent and the Grenadines for Canada where she joined the Vee Jay's team and was soon representing the Ontario Open Team. Rosemary started her own netball team, Wings Underneath. Within a year, she added a soccer team and began building her sports her club. Two years later, Rosemary joined forces with her sister, Kathy Ann Forbes, and created Success Sports Club. Rosemary eventually branched out in to Radio and soon had Success Radio up and running. Today, Success Sports Club--SVG is sponsored by the Vincy Liberators Inc. Rosemary says her goal is to continue creating platforms for continuing education.

Our Honourees for 2019

Professional Accomplishment Evans B. Morgan

Mr. Evans B. Morgan was born in Richland Park, St. Vincent and the Grenadines. He is the last surviving member of the first legislative council that was elected, after universal adult suffrage, in St. Vincent and the Grenadines. In 1951, Morgan and his colleagues, Rudolf E. Baynes, Julian A. Baynes, George H. Charles, Ebenezer T. Joshua, Samuel E. Slater, Herman F. Young and Clive L. Tannis contested the first general election after voting rights were granted to Vincentians.

Their political party was known as the Eight Army of Liberation (EAL). The party was an amalgamation of The United Workers and the Peasant and Ratepayers Union and their campaign slogan was "A Better day, A Brighter Day and a More Prosperous Day". The election was a land-slide victory for the eight comrades as all eight of them won their seats with Morgan gaining 80% of the vote in his constituency. In 1953, however, internal conflicts led to a breakaway faction that then formed the Peoples Political Party. The EAL did not contest another election. Morgan, 23 years of age at the time was the youngest of his colleagues to be on that first legislative council and today, at 93 years of age he is the only surviving member of the EAL. He had this to say "we worked very hard to try and bring about a better day for the people. One of the changes I am happy that we made was to introduce the West Indian Reader into the school system which replaced the Royal Reader. This was a 'big leap' at that time as we were up against many challenges.

Morgan's love of education was evident in the fact that at 13 years of age he became a pupil teacher and at 18 years graduated with honours from the Caribbean Union College in Trinidad. He returned to St. Vincent and the Grenadines and began teaching at the Stubbs Government School. At 19 years old he became a Head Master at Stubbs and it was while teaching at Stubbs that his colleagues encouraged and supported him to run as a candidate for the Parliament of St. Vincent and the Grenadines.

Life after politics for Morgan revolved around studying and working. In 1955, he earned a Master of Science in economics and was recruited by Shell Oil Company as an economist and served for many years. Morgan relocated to

Canada in 1968 and worked as a Chief Cost Accountant with Northern Telecom. Later, he was recruited by the government of SVG to be the deputy accountant general but during his transition to that role, there was a change in government and he went to work elsewhere. After moving to Canada, Morgan joined the Ontario Ministry of Housing and on retirement worked with the Ontario Conference of Seventh-Day-Adventists as Chief Internal Auditor until fully retiring.

Morgan and his wife Erene, a registered nurse, are very much involved with their Church. Morgan still teaches Sabbath school and gets involved in the church's community outreach programs. Over the years, Morgan and Erene, through their church, have supported schools in SVG by sending home computers and other items. In the flash floods of 2013, they worked with their church to raise funds and sent thousands of dollars to their counterpart church in SVG to help the victims of the flooding. His wife Erene had this to say, "Evans cannot keep still, when he was 90 he was still mowing the lawn, now at 93, he still wants to potter around in the garden. He wants to go out and do things. Every day, he gets up and asks "where are we going today?" Morgan and Erene have two children, Mark, a Senior Project Manager and Gail, a lawyer. When asked to what he owed his longevity, Morgan quickly answered, "I played cricket. I played until I was 83 years, (He was instrumental in forming the Etobicoke Cricket League) so if you want to live long like me, trust in God, don't smoke, don't drink and play cricket".

Music David Morgan aka "Yellows"

Carlos David Morgan, aka "Yellows" as he is known professionally, was born in the town of Barouille, St. Vincent and the Grenadines (SVG). Yellows first sang in public at the tender age of 15 years and has been entertaining audiences throughout SVG and North America since then. A house-hold name in SVG and North America, Yellows credits the time he spent singing in the choir at Sunday morning church services in Barrouallie for helping to shape his voice and his singing career. After placing second at a Calypso competition at his high school, Yellows joined the band, Resurrection, in the mid-1980's as lead vocalist.

However, it wasn't until he toured with the band, Astericks, throughout the Caribbean, that he progressed musically. Yellows moved to Canada in 1988 and began signing with various bands across the country. In 2000, he became the lead vocalist with Moses Revolution, then known to be the #1 Soca band in Toronto. In 2002, he placed second for the Canadian Soca Monarch title and held that spot from 2003 to 2005. He placed second in 2012 in a New York Song Competition and took home the Soca title for the St. Vincent and Grenadines in 2013. The Saint Vincent Termination of Association Order 1979

Laid before Parliament in draft

Made - - - - - 26th July 1979

Coming into Operation 27th October 1979

At the Court of Saint James, the 26th day of July 1979

Present,

The Counsellors of State in Council

Whereas Her Majesty, in pursuance of the Regency Acts 1937 to 1953, was pleased, by Letters Patent dated the 16th day of July 1979, to delegate to the six Counsellors of State therein named or any two or more of them full power and authority during the period of Her Majesty's absence from the United Kingdom to summon and hold on Her Majesty's behalf Her Privy Council and to signify thereat Her Majesty's approval for anything for which Her Majesty's approval in Council is required:

And whereas a draft of this Order has been laid before Parliament in accordance with section 17(2) of the West Indies Act 1967(a) and has been approved by a resolution of each House of Parliament:

Now, therefore, Her Majesty Queen Elizabeth The Queen Mother and His Royal Highness The Prince Charles, Prince of Wales, being authorised thereto by the said Letters Patent, and in pursuance of the powers conferred by section 10(2) of the West Indies Act 1967 and all other powers enabling Her Majesty, do hereby, by and with the advice of Her Majesty's Privy Council, on Her Majesty's behalf order, and it is hereby ordered, as follows:—

1.—(1) This Order may be cited as the Saint Vincent Termination of Association Order 1979.

(2) This Order shall come into operation on 27th October 1979.

2. The status of association of Saint Vincent with the United Kingdom is terminated as from the date on which this Order comes into operation.

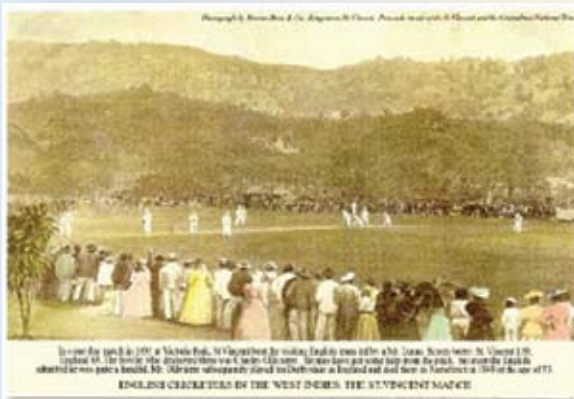

Charles Ollivierre Routs English Cricketers at Victoria Park in 1895

Transcript of Photograph Caption:

In a one-day match in 1895 at Victoria Park, St. Vincent beat the visiting English team led by a Mr. Lucas. Scores were: St. Vincent 159, England 63. The bowler who destroyed them was Charles Ollivierre. He may have got some help from the pitch, but even the English admitted he was quite a handful. Mr Ollivierre subsequently played for Derbyshire in England and died there in Pontefract in 1949 at the age of 73.

La Soufriere erupts, 1979

In the 1979 Soufriere eruption the ash was carried 90 miles away to Barbados and perhaps even further. A year later, farmers in St.Vincent were recording giant growth in their crops especially the height of corn plants.

- 1985 The new SVG flag came into use officially
- 1987 SVG elected to one of the Vice-Presidencies of the United Nations General Assembly - the first English speaking Caribbean country to have attained that honour
- 1991 Death of Ebenezer Theodore Joshua (March 14) - first Chief Minister of SVG
- 1997 Death of Robert Milton Cato, father of the Nation (February 10) - 1st Premier and Prime Minister
- 2002 Joseph Chatoyer declared first national hero of St. Vincent and the Grenadines (March 14)
- 2007 Opening of the Yurumein Taiwan Bridge at Rabacca

A Brief History of the St. Vincent and Grenadines Association of Toronto Inc. ... How it all began

(The following article was written by Ms Elma Gabriel, past president of the Association for the January, 2009 issue of Insight Newsletter. Edited for space by Prudence Morton)

In 1968, Dr. Allan Liverpool, a Vincentian living in Toronto, received a letter, dated 10th October, 1968 from the Secretary of the Arnos Vale Playing Field. The letter asked Dr. Liverpool if he could request financial assistance from Vincentians in Canada to help with the development of the Arnos Vale Playing field. This sparked the beginning of the "Vincentian Association of Toronto". On receipt of the letter Dr. Liverpool invited all interested Vincentians to a meeting on Sunday, November 24, 1968 to discuss raising funds for the Playing Field Project, and also for the possibility of formulating a Vincentian association in Toronto. Following discussions at that gathering, an initial meeting of the Association was convened on Sunday, December 1, 1968 at 2 PM at Club Tropics, 12 Queen Street East, Toronto. Club Tropics was owned by Stilly Fraser and Rufus Jarvis, two nationals of SVG who donated their venue for the meeting. The notes of the meeting revealed a sense of "fierce urgency of now". What has to be done? How will it be done? The meeting was a crossroad to the beginning of something for their homeland and the foundation for what is now The St. Vincent and Grenadines Association of Toronto Incorporated (SVGAT). The following officers were appointed:

President, Dr. S. Allan Liverpool
Vice President, Mr. Fred Isaacs
Secretary, Ms. Shirley Sutherland
Treasurer, Ms. Edna Hunte
Public Relations Officer, Mr. Caley Bonadie

The officers set a course and never lost sight of the objective -- giving priority to the Playing Field Project. By the second meeting on December 14, 1968, a collection of \$800.00 (CAD) was raised and forwarded to St. Vincent and the Grenadines for the playing field project. The third meeting was held in January 1969, and the fourth meeting on the third Sunday in February. A draft Constitution was discussed, with clauses ratified and passed. Before the meeting ended, the President (Dr. Allan Liverpool) expressed his appreciation to the team for their accomplishments. He also offered his regrets that due to commitments to his medical profession, he had to tender his resignation. The next meeting was scheduled for the third Sunday in March 1969. Mr. Hermus Liverpool, because of his past involvement in a similar organization in Montreal, was asked to take over as President.

The Vincentian Association of Toronto, as it was named at the time, held a Statehood Ball on October 24, 1969 to commemorate the granting of Associated Statehood status on St. Vincent and the Grenadines. Ms. Pamella Venner was selected as Statehood Queen and represented the Association at the celebrations in St. Vincent and the Grenadines. The airfare was provided by BWIA. Ms. Joan Hewitt, first runner-up received a passage to New York or Montreal donated by Air-Sea-Land Travel.

The Association asked Attorney M. A. Zuker to represent the Association at The Department of Finance & Commercial Affairs in Toronto and to file an application for Letters Patent on November 23, 1970. On February 26, 1971 a Letters Patent was rendered by the Province of Ontario in the name "The St. Vincent Association of Toronto" with the Chartered objectives: (a) To provide a forum for the non-political discussion of matters, social, cultural, recreational and any other topics of interest to members. (b) To provide any form of assistance, wherever such is possible, to groups or institutions in St. Vincent and/or, where the association sees fit. The first and original Directors of the Corporation were Edmund DeFreitas, Alfred Issac, Shirley Margaret Sutherland and Edna Hunte. The Corporation was ordained and declared to carry on with the purpose of gain for its members, and any profits or other accretions to the corporation should be used in promoting its objectives. Our founding fathers and mothers championed the formulation of an organization which was to serve for generations to come.

Dear Dr. Liverpool,

You will no doubt have heard, with much delight, of the efforts being made here in St. Vincent to provide a National playing Field at Arnos Vale, which will cater for all branches of sport, and allow St. Vincent to be hosts to international and intercolonial cricket, football, netball, etc. teams. So far we have not been able to have important games here, due to lack of a first class ground and of proper pavilion facilities.

The present Government is very interested in this project, and work on levelling and drainage of the 22 acres donated by them has already started. They have passed legislation - The Arnos Vale Playing Field Ordinance, a copy of which I enclose - which will ensure that things are done properly, and a Board, the Arnos Vale Playing Field Board, has already been appointed in accordance with the Ordinance. The target for the project is close to \$500,000, but it is designed to be carried out over a period of five years in three stages. The first stage is for levelling and drainage of the cricket and athletics field, the construction of turf wickets and athletics facilities and of a players' pavilion and is to cost \$120,000.00 - this is what we are aiming at for the present. I enclose ten (10) copies of a brochure which will give you an idea of what is planned.


As one who is genuinely interested in your homeland, the Board feels that you will wish to associate yourself with the project, and wonder if you would organize a fund among the many Vincentians (and others) in your area who may be interested in contributing to the venture. We ask this favour, well

knowing that your many duties keep you well occupied but we hope, nevertheless, that you will be able to assist us in whatever way you can.

The Board is working hard at home to raise part of the amount required for the first stage, and we have pledges from the Jaycees, Lions and the National Playing Fields Association of the U.K. The target is high, however, and any receipts from whatever source, will be of help.

I hope to hear from you soon. Please accept the best wishes of the Board, and their thanks in advance.

With a capacity of 12,000 seats, the stadium at the Arnos Vale Playing Field was built in 1996. Regarded as one of the larger stadiums in the Caribbean, it got its first cricket test match in 1997, when the West Indies played the touring Sri Lankan team.

Warm-up matches for the 2007 ICC World Cup were held here. The stadium is located next to the E.T. Joshua Airport on Mainland St. Vincent.

There are approximately One hundred Vincentians in the Toronto area, a minimum goal of One thousand Canadian dollars (\$1,000), is the objective, this is an average donation of Ten Dollars (\$10.00) each, so let us make this appeal a gigantic success. Would you kindly adhere to the following as regards your donation.



SVGAT *Early Cultural Group*



The origin of The St. Vincent Cultural Group (Toronto)

The St. Vincent Cultural Group was founded in 1979, when UNESCO proclaimed that year as the International Year of the Child. The proclamation was signed on January 1, 1979 by United Nations ... Six members of SVGAT, Keith Homer, Hubert Phillips, St Elmo Hunt, Barbara Toney, Edson Huggins, and Elmond Jackson each put together \$100.00, contacted some kids and put on a show in honour of the Children, and to commemorate the "Year of the Child".



Practices for the show took place at Keith Homer's house. After the first show, the children were so energized and motivated that they asked Keith and the others to keep the group going.

The adults discussed the possibilities and solicited the space at the then newly opened Northwood Community Centre. The St.Vincent Cultural Club is recorded in the Municipality as the first group to use the Northwood Community Centre facilities. In the main hallway hangs a picture of the late Keith Homer Sr.

To accommodate the group's annual objective, Keith, St.Elmo and Hubert would pick up the children at their homes, take them to practices and then take them back to their respective homes.



The Maypole dance became one of the primary attractions at the shows, adding greater transportation demands due to popular bookings to perform at shows. However, the adult volunteer transport officers were so encouraged by the enthusiasm of the children that they sorted out ways to form a balance between their family, work, and volunteering for their community kids. And if that was not enough, the children added to their demand a Caribana band. In addition to preparing the costumes, on Caribana day the kids were dropped off by their parents, as it was the responsibility of the volunteers to care for the kids on that day.

The children of that era are now grown up, while the St.Vincent Cultural Group is currently in a defunct stage, pending the revamping of what was no doubt one of our most vibrant and promising youth cultural initiatives of the 70's.

The St. Vincent and the Grenadines Community in the Greater Toronto Area on Sunday, September 22 launched a committee called CARI-ON, an acronym for Conducting Active Relief Impacting Our Nation. Its mission is to take a proactive stance to help mitigate some of the inherent challenges faced during, and in the aftermath of a disaster by providing timely relief to sustain essential functions.

Disasters strike at any time without notice, and as we all know, the Caribbean Region is prone to natural disasters. It is a phenomenon that we can expect each year - be it hurricanes, volcanic eruptions, storms or earthquakes. These disasters seem to be occurring more forcefully and frequently due to the effect of climate change. We need to pay attention and get organized.

Over the years, the various Caribbean communities in the Diaspora have reacted well but not in any organized manner. Following an appeal that was made last year, a number of communities here in the Greater Toronto Area are putting structures in place by forming disaster preparedness committees to develop plans to enable the communities to respond when a need arises. Grenada, Dominica and St. Vincent and the Grenadines communities have so far launched committees. In addition, the Antigua & Barbuda Emergency Relief Fund was established years ago.

CARI-ON is a member of an umbrella organization in the GTA called CCaDiRA which is made up of a number of Caribbean communities' committees established for the same purpose. CARI-ON, through CCaDiRA will partner with international organizations like Global Medic and the Canadian Red Cross and channel its assistance through NEMO and the other Caribbean governments' established agencies to respond to

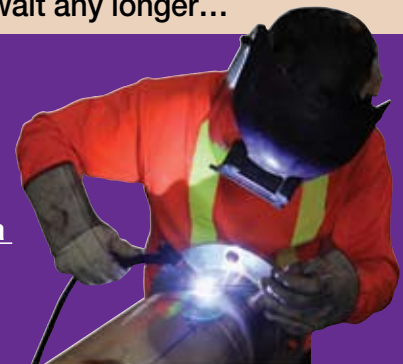
