#### SVGAT'S ANNUAL GENERAL MEETING

The annual general meeting of the Association will be held on Sunday, January 26, 2025 @ 4:00 p.m. At that meeting, there will be a review of the activities of the Corporation for 2024, the presentation of the financial report and the election of board members to replace those whose terms have expired. All members of the Association are invited to attend and to make themselves available to serve.

#### **VOTING ELIGIBILITY**

In order to cast a vote at the upcoming annual general meeting, a person has to be a financial or honorary life member in 2024. According to the bylaws, a person who is not a financial or honorary life member can be elected to serve on the board. If such a person is elected, the person has up to ten (10) days following the election to pay his or membership fee and become a member. Membership fees are paid annually and are good up to December 31 of the year in which they are paid, however, there is a grace period ending March 31 where those members remain financial.

## **BOARD OF DIRECTORS ELECTION PROCESS**1) Introduction

According to paragraph (22) of the St. Vincent and Grenadines Association of Toronto (hereinafter "The Association") By-laws, each year Board seats are opened for elections according to numbers. Elections will take place during the Annual General Members Meeting that is normally held in the month of January. For 2025, the Annual General Members Meeting will be held on January 26.

In accordance with the Province of Ontario Corporation Law, a person can be elected as a director without being a member of the Corporation. If a person who is not a member is elected, then that person has up to ten (10) days following the election in which to become a member.

The logistic of the elections and its running will be managed by an Election Supervisor. Firstly, there will be the election of a president, then there will be election for the remaining directors.

#### 2) Eligible Candidate

In order to be nominated for and elected as president and/or director, the person must:

- Be 18 years of age
- Not be a declared bankrupt
- Not be prohibited from being a director or promoter of the Association
- Be of sound mind •

Agree to be nominated

- Must be present at the meeting
- State his/her qualifications and why he or she feels they are fit to serve the Corporation in that capacity.

#### **Eligible Voters**

Only persons fulfilling the following criteria are eligible to vote:

- Any financial member of the Association in good standing. Good Standing in this context refers to a member who has paid his/her membership dues for the year 2024. All paid members for the 2024 year continue to be members up to March 31st, 2025.
- Honorary Life Members.

The following voting criteria apply to all members. Members present at the election have both a self-voting right as a candidate if they are board members seeking reelection, and as ordinary members to nominate and elect persons to serve on the board.

#### 4) The Election Process

### 4.1) Nominations & Voting

Nomination: The nominator must state why he or she feels that the nominee is a good candidate for being the president/director of the Corporation. If the nomination is seconded then the nominee must state his or her qualifications for being a president/director and whether he or she feels that they are fit to serve the Corporation in that capacity. The Election Supervisor shall ask if there are any more nominations. If none is forthcoming, he/she asks for a motion that nominations to be closed, seconded and agreed upon.

**4.2) Voting:** Voting takes place when nominations are closed. The following voting criteria apply to all candidates:

A candidate, present at the election, either has a self-voting right as a candidate or as an ordinary member if they are a board member seeking reelection.

#### 5.) Election of President & Directors

- **5.1) Election of President:** The president is elected to serve as president for one year. The president will automatically become a director and his/her term of office as a director will be determined when the directors are elected. Nominations and voting will follow the above-noted process.
- **5.2) Election of Directors:** For 2024, four directors will have completed their terms. Therefore, there will be four vacancies to be filled as follows:

One director to be elected for a three-year term

Three directors to be elected for a one-year term

The election results are published later on the Association's website.

The Supervisor of Elections will declare the names of all candidates who have been elected.

The elected president may choose to give some remarks at this point.

At this year's AGM on January 26, four (4) directors positions will be up for elections, namely, three directors for two-year terms and one director for a one-year term.

#### HURRICANE BERYL RELIEF EFFORTS

The Corporation hosted a food and bake sale on September 21 at St. Stephen's Anglican Church, Downsview to raise funds for the victims of Hurricane Beryl which caused severe damage in many Caribbean countries and particularly the Southern Grenadines. The event which ran from 12:00 noon to 5:00 p.m. saw scores of individuals dropping by to purchase some Vincy delicacies including roast breadfruit, tri-tri cakes, sweet bread, goat head soup, bread and buns, as well as popular drinks like sorrel, mauby and ginger beer. Just over \$2,000.00 was raised to help the people of the Southern Grenadines.

CARI-ON SVG Disaster Preparedness spearheaded a collection drive to gather and ship clothing, tools and machines to the affected individuals.

#### 2025 TORONTO HARBOUR BOAT CRUISE

The SVGAT and the Toronto SVG Support Group (TorSVGSG) will again coordinate the summer boat cruise to raise funds for supporting the activities and programs of both organizations. The annual popular

#### **CCAC NEWS**

The Council of Caribbean Associations-Canada (CCAC) of which the SVGAT is a founding member held its bursary and scholarship presentations on November 17 during which it presented 5 bursaries of \$3,000.00 each to students of Caribbean descent who are attending colleges and universities. Two other students each received full tuition-paid scholarships to attend Seneca Poly-technic and George Brown College for up to four years.

This is an election year for the CCAC. The AGM is scheduled for May 26 when new board members will be elected and committees appointed.

The CCAC has ten active member associations – Alliance of Guyanese Canadian Organizations, Antigua & Barbuda Association of Toronto, Barbados Canada Association, Commonwealth of Dominica Ontario Association, Grenada Association Toronto, Montserrat Association Toronto, Nevcan Cultural Association, St. Kitts & Nevis Association of Toronto, St. Lucia Association Toronto and St. Vincent and Grenadines Association of Toronto.



#### SVGAT'S ADOPT-A-CHILD PROGRAM

The Corporation is into the second year of the fourth cycle of the Adopt-A-Child Program. The five-year terms ran from 2008 to 2012, 2013 to 2018, 2019 to 2023 and 2024 to 2028 where students from schools across St. Vincent and the Grenadines are provided with funding to support them at school. The funds are entrusted in each students' account with the respective

schools and a committee including teachers and members of the parent-teacher committees oversee the students' progress at school.

In this cycle of sponsorship, 12 students from the Barrouallie Anglican, Belmont Government, Bequia Anglican Primary, Evesham Methodist, Fitz Hughes Government, Georgetown Government, Kingstown Anglican, Lowmans Windward Anglican, Mary Hutchinson Primary, Owia Government, Rose Hall Government and School for Children with Special Needs – Kingstown.

With so many natural disasters affecting St. Vincent and the Grenadines, there is a growing need for those of us who can to do our best to support families there, especially with ensuring that the students are provided with at least the basic needs to get a proper education. If you are so inclined to join as a sponsor in this program, kindly contact any member of the board of directors. The current commitment is CDN\$720.00 per year which converts to approximately EC\$1,200.00, so that the student receives EC\$100.00 per month.

## IMMIGRATRION WATTERS

IMMIGRATION MATTERS: EXODUS Contributed by: Sandra Sutherland, RCIC-IRB

The Bible tells a story of the Israelites embarking on an exodus to flee from their enslavement in Egypt to Canaan, the promised land flowing with milk and honey. Today people flee their countries due to persecution and other crisis in pursuit of a better life in a country perceived to be filled with opportunities. There are stories of Americans planning to migrate to Canada because of the current political climate in the U.S. Whatever the reasons may be, many foreign nationals choose to migrate to the U.S.A or Canada. With the looming threat of mass deportation in the U.S.A the expectation is that Canada will likely be viewed as "the promised land" as less and less foreign nationals get disenchanted by the idea of migrating to the U.S. It is fair to say that, during 2025 and over the next few years, Canada can expect to face mass migration. With the potential of more Americans moving here, does it mean that Canada will limit the number of other foreign nationals they let in?

It is estimated that Canada has between 300,000 and 600,000 undocumented immigrants. There is concern that the Canadian government may, within the next couple of years, follow suit and implement a deportation plan similar to that of the U.S. Immigration, Refugees and Citizenship Canada (IRCC) intends to limit the number of immigrants they accept as permanent and temporary residents starting this year (2025).

In October 2024 IRCC released details of their 2025-2027 Immigration Levels Plan. The volume of foreign nationals slated to be admitted to Canada as permanent residents will decrease from 500,000 to 395,000 residents in 2025, 380,000 in 2026 and 365,000 in 2027. The majority of admitted perma-

nent residents will be from the economic/skilled worker streams. 22% are slated to come from the family sponsorship category and 15% are expected to come from the resettled refugees and protected persons category. The target for applicants applying for permanent residency based on humanitarian and compassionate grounds and/or as part of public policies is 21,200. Temporary resident targets (specifically international students and temporary foreign workers) shall be reduced to 5% of Canada's population by the end of 2026. The good news is that more than 40% of overall permanent resident admissions in 2025 shall be students or workers already in Canada.

So, with more Americans and other foreign nationals setting their sights on migrating to Canada what are we likely to expect? Reducing the number of permanent and temporary residents could result in IRCC tightening eligibility criteria, refusing more applications, reducing intake caps on study permit applications, and/or restricting or closing existing programs. It was announced on January 3, 2025 that IRCC will not be accepting any new applications for the parent and grandparent (PGP) sponsorship program this year. As we progress through this new year more and more changes will be announced.

The government of Canada states that they are reducing the immigration levels so as to alleviate pressures on housing, infrastructure and social services. They acknowledge that temporary and

permanent residents play a key role in supporting economic growth, addressing labour market shortages, and contributing to the diversity of communities across Canada. At a time when mass migration may be imminent the Canadian government is seeking to reduce the amount of permanent and temporary residents it lets in. Could any of this be counterproductive? What will foreign nationals encounter as they set about their journey to migrate to Canada? How will the Canadian government

actually deal with an onslaught of migrants over the next few years?

# **News From SVG**

#### GEARING UP FOR ELECTIONS

Constitutionally due by February 2026, the political parties in St. Vincent and the Grenadines are actively preparing for general elections which some predict could be called as early of November this year.

While Prime Minister, Dr. Ralph Gonsalves has indicated his intention to lead the Unity Labour Party for the sixth consecutive term in office, a number of government ministers have indicated that they would not be considering seeking re-election. The party is still in the process of recruiting suitable persons to replace those who would bow out.

Meanwhile, the New Democratic Party, the main opposition party has indicated that it has its full complement of 15 candidates to make a sixth attempt to dislodge the chains of government from the ULP. Among the NDP's hopefuls is Dr. Kishore Shallow, current president of West Indies Cricket.

A new party, the National Liberation Movement was recently launched by Dr. Doris Charles, a former diplomat and wife of a former Government Minister. The party described itself as "the voice of change and transformation" and is offering itself to the people of St. Vincent and the Grenadines as "the only viable alternative for our people, to take the country further into the future with hope, prosperity and sustainable growth for ALL,

### **Non-European Visitors to UK Need ETA**

The UK Government has introduced Electronic Travel Authorisation (ETA) for millions of visitors who pass through the UK border every year,

including six million from the United States, Canada, and Australia.

Since Nov. 27, 2024, all eligible non-European visitors can apply for an ETA and will need one to travel to the UK from Jan. 8, 2025.

In 2025, the UK will open ETA to eligible Europeans, who will be able to apply from March 5, 2025 and will need an ETA to travel to the UK from April 2, 2025.

From April 2025, all visitors to the UK who do not need a visa for short stays and who do not already have a UK immigration status will need an ETA.

The expansion follows the successful rollout of ETAs to Gulf Cooperation Council nationals earlier. In the first half of 2024, over 243,000 Gulf nationals were issued with ETAs and can now benefit from smoother, easier travel to the UK for short trips. It is stated that ETAs will enhance security through new technology and make the UK border more efficient, preserving the UK's appeal as a dynamic, diverse, and exciting destination to visit,".

All travellers to the UK — except British and Irish citizens — will need permission to travel in advance through either an ETA or an eVisa. Replacing physical immigration documents with eVisas lets UK visa holders use online immigration services, take control of their data and prevent against documents being lost, stolen or tampered with.

# RENOVATED PORT KINGSTOWN HEADING TOWARDS COMPLETION

Minister of Finance Hon. Camillo Gonsalves said the Port is now 82 percent complete and currently employs 169 Vincentians. He said that Vincentians can expect for the modern Kingstown port to be commissioned and fully operational by mid-2025.

Budget 2025 which was recently debated in parliament, allocates \$92.6 million to the completion of this phase of the modern port project. This will be used to complete ongoing works, namely:

- Construction of the container freight station building;
- Construction of the administrative building, maintenance workshop —including, internal finishing, elevator installation, and solar panel installation;
- Construction of the maintenance garage;
- Completion of the Break Bulk Warehouse;
- Installation of pavement;
- Installation of operational facilities;
- Terminal utilities manholes, ducting, potable water and fire lines, sewer lines, etc.;
- Landscaping;
- · Roadworks; and
- Commissioning and testing

The renovation began in early 2024 with the dredging of sand from shores around the Argyle International Airport and deposited in the Kingstown Harbour.



On November 1st 1968, Dr Allan Selwyn Liverpool wrote a letter to the Vincy Community in response to a request from SVG asking for assistance to refurbish a Playing Field. In a footnote to that letter, he put out a call to all concerned Vincentians to attend a meeting at Club Tropics on Queen Street, Toronto. This meeting was to form an organization to fill a growing need in the community for a networking focal point, a centralized gathering to attempt to address some of these needs here in Toronto and at Home.

On December 1st 1968 they formed the SVGAT and gave us a HOME Away from HOME.

Over the years a group of adults have selflessly given their Time, Effort and Expertise to grow that organization. Today we sit on the threshold of a new era. Here we need to seriously reflect on:

Where we have been?
What we have done?
Where we are?
Where we want to go? and
What we need to do to get there?

We do know that any organization needs Pioneers and Settlers in order to grow and to effectively achieve their goals. We have Settlers, an abundance of Settlers. Where are the Pioneers?
